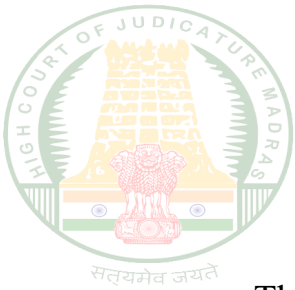

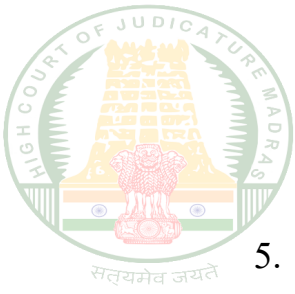
2. Considering the nature of relief, the Learned Government Advocate (Criminal Side) was heard.

5. With the above direction, this Criminal Original Petition stands disposed of.

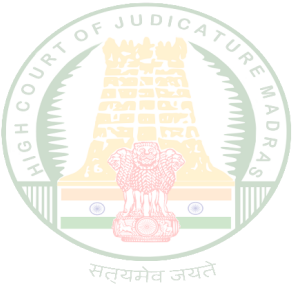
